ORDINANCE NO. 1-2013

ORDINANCE TO ESTABLISH VOTING DISTRICTS OF THE  
GRANT COUNTY COUNCIL

WHEREAS, the County Commissioners of Grant County, Indiana, have previously established voting districts for the Grant County Council which has provided for four (4) districts; and

WHEREAS, it is desirable to modify those voting districts based upon current census numbers; and

WHEREAS, the new districts should be established beginning on the date of passage.

NOW, THEREFORE, BE IT ORDAINED by the Commissioners of Grant County, Indiana, as follows:

1. There is hereby established four (4) County Council Voting Districts for Grant County, Indiana.

2. It is hereby established that County Council District 1 of Grant County, Indiana, shall consist of the following precincts:

Center 8, Center 9, Center 10, Center 11, Center 13, Center 14, Center 15, Center 16, Center 17, Center 20, Mill 1, Mill 2, Mill 6, Mill 9 and Mill 10

3. It is hereby established that County Council District 2 of Grant County, Indiana, shall consist of the following precincts:

Center 1, Center 2, Center 3, Center 4, Center 5, Center 6, Center 7, Center 12, Center 18, Center 19, Center 24, Van Buren, Washington 1, Washington 2, Washington 3 and Washington 4.

4. It is hereby established that County Council District 3 of Grant County, Indiana, shall consist of the following precincts:

Franklin 1, Franklin 2, Franklin 3, Franklin 4, Franklin 5, Franklin 6, Franklin 7, Green, Pleasant 1, Pleasant 2, Pleasant 3, Pleasant 4, Pleasant 5, Pleasant 6, Pleasant 7, Richland and Sims

5. It is hereby established that County Council District 4 of Grant County, Indiana, shall consist of the following precincts:

This Ordinance shall become effective on the date of adoption.
